JOB PURPOSE AND RESPONSIBILITIES

Core Responsibilities: -

- Provide a high-quality counselling service to pupils experiencing a wide range of emotional problems, working within the Code of Ethics and Practice of UKCP/BACP.
- Provide support, advice and guidance to pupils, parents, guardians/carers and staff.
- Maintain appropriate records, ensuring these are secure.
- Provide a regular report for the Headteacher and Deputy Head, detailing the numbers of pupils using the service and an overview of the problems experienced.
- Liaise with the Deputy Head with regards to pastoral responsibilities.
- Establish contacts with agencies for referrals.
- Outline to staff and pupils the role of the counsellor and the boundaries of confidentiality.
- Provide support to those staff who support pupils.

- To complete termly and half termly reports regarding impact, outcomes and key themes for Deputy Head to present to Trustees.
- Conduct small group sessions where needed.
- Identify any further needs within the school, such as girls' support groups.

General Requirements and Responsibilities: -

- To promote and uphold the Catholic ethos of the school.
- To play a full part in the life of the school community, to support its distinctive mission and ethos and to
 encourage staff and pupils to follow this example. Ensure that the school guidelines have been consulted
 and followed.
- Work towards and support the school vision and Strategic Leadership Team in creating a culture for learning, high standards of achievement and success.
- Support and contribute to the school's responsibility for the welfare and safeguarding of students.
- Work within the school's health and safety policy to ensure a safe working environment for staff, students and visitors.
- Maintain high professional standards of attendance, punctuality, appearance, conduct and positive, courteous relations with students, parents and colleagues.
- Engage actively in the performance review process, attend meetings and staff training.
- Undertake other reasonable duties related to the job purpose required from time to time.

- Counselling or psychotherapy qualification to Post-graduate Diploma or Masters level, with a minimum of 1 year's post qualification experience
- Achieved or working towards BACP or UKCP registration
- Specific qualifications in working with children and adolescents in a therapeutic capacity
- Good understanding of attachment and child development as well as specific developmental and other issues faced by adolescents
- A sound understanding of child protection and experience of working within the policies and procedures of an organisation
- Knowledge of the UKCP/BACP ethical framework and evidenced ability to apply this to practice
- Awareness of and openness to positive psychology theory and practice
- Knowledge and use of stress reduction techniques
- Knowledge and awareness of child mental health diagnoses.
